Full scholarships for seven selected master's programmes at German universities

These study programmes

- focus on public policy, good governance, international relations, public management, public administration, civil society, social protection, peace and conflict studies, development and socio-economic policies
- have an international orientation and are mainly taught in English

All scholarship holders will be offered additionally

- studying and special tutoring in groups at their host university
- networking events and tailor-made workshops
- German courses in Germany for up to six months before starting their master's programme

Target group

Graduates from developing and emerging countries (Bachelor or equivalent)

- with a well-qualified first university degree in Social and Political Sciences, Law, Economics, Public Policy and Administration
- willing to actively contribute to the social, political and economic development of their home countries/regions
- who have already gained practical experience relevant to the programme (professional experience, internships or other activities in their community)

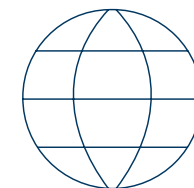

Network

- the study programme collaborates with a wide-ranging network of experienced and internationally renowned practitioners and academics from high-ranking institutions
- students have the chance to visit social protection actors in Germany and neighbouring countries
- the practical term and the group of peers with relevant work experience offer students the opportunity to broaden their network and gain hands-on experience



Master's Programme

Content

- 1st semester: held in Germany where students interact with classmates and professors
- 2nd semester: classes will take place online. Students have the option of returning to their respective countries or staying in Germany. The online term offers a combination of different teaching methods that leave students with enhanced digital skills as well as self-organisation and collaborative working skills
- 3rd semester: students will apply their theoretical knowledge in an internship at an organisation of their choice. The practical term can also be used to collect data for their master's thesis
- 4th semester: writing the master's thesis

Methods

Students acquire technical as well as methodological skills to design, reform, analyse and manage social protection policies.

Organisation & Language

- a two-year programme which offers an interdisciplinary and in-depth study of social protection systems
- taught in English

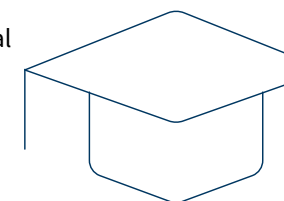
Target Group

Location & University

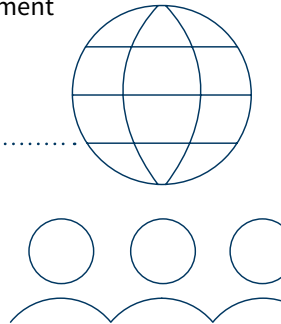

Master's Programme

Content

The master's programme in Development and Governance combines teaching in several Political Science sub-disciplines (Development Studies, International Relations, Peace and Conflict Studies, Administration and Policy Studies, Comparative Politics of European Union, Sub-Saharan Africa or East Asia). The main emphasis is on acquiring knowledge of the relevance of different tiers and forms of governance processes (local, national, international), training students' analytical skills and providing them with policy- and region-specific expertise.

Methods

The programme provides a mixture of different teaching and learning methods, with courses not only of theoretical, but also empirical relevance linked to the students' previous academic and professional experiences.

All courses are designed to either better understand or question established conceptual dimensions of good governance, to discuss the framework conditions for the emergence of different governance arrangements or to focus on their effects on development.

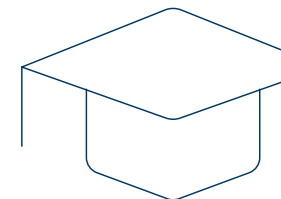
Our programme addresses students with an academic background in Social Science and working experience related to the subjects of Development and Governance.

As one of the youngest and oldest universities in Germany, University of Erfurt focuses on tackling the major challenges of our time, relying on international academic cooperation.

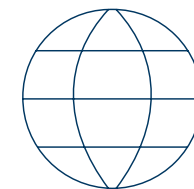

Master's Programme

Content

Students learn to:

- understand the theoretical underpinnings of political processes
- develop critical, analytical and practical abilities for policy-making

Students specialise in two of four subject areas:

- International & Global Public Policy
- Development & Socio-Economic Policy
- Conflict Studies & Management
- Non-Profit Management & Social Entrepreneurship

Methods

We focus on practice-oriented study and research in small groups, allowing for close interaction between students and teaching staff, who are equipped with practical experience in their fields of teaching.

Our core curriculum combines:

- quantitative and qualitative approaches to public policy analysis and problem-solving
- foundations of public administration, public finance and economic policy analysis
- management and leadership skills as well as ethical considerations for the public sector

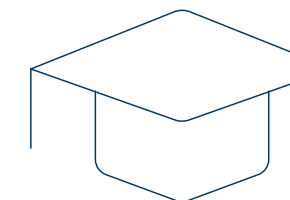
The MPP is designed for highly talented and motivated graduates with professional work experience, aiming for executive positions in the public or non-profit sector.

The University Magdeburg is one of the youngest universities in Germany and attracts students from all over the world thanks to its excellent reputation and wide range of courses as well as leisure activities.

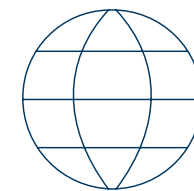

Master's Programme

Content

PACS is an interdisciplinary study programme with a focus on political science and sociology. The close relation between students and lecturers allows for interactive teaching and flexible curricula to meet student interests.

- additional courses offered in Journalism, Philosophy, History and many other subjects
- focus on peace and conflict research, conflict analysis and management as well as peaceful approaches to conflict and violence
- students choose three out of four specialisations: Regional/ Global Orders, Sustainable Development, Global Justice, and Media and Violence

- a minimum of 60 ECTS credits in one or several of these disciplines
- out of the 60 ECTS, 10 ECTS must result from empirical research methods, such as data collection, data analysis and statistics
- adequate English skills

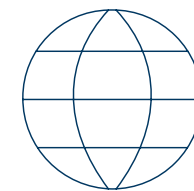

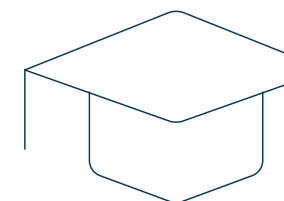
