Call for the selection of Visiting Professors 2025



TITLE I - GENERAL INFORMATION

ART. 1. Object

Sapienza launches a selection process aimed at funding Visiting Professors for the conduct of joint research and teaching activities to be carried out between January 1, 2026, and December 31, 2026.

ART. 2. Proponents

- 1. By "Proponents", we refer to first- and second-tier Professors, confirmed Researchers, fixed-term Researchers, and RTTs at the closing date of the Sapienza call, who apply aimed at inviting a foreign Visiting Professor for joint research and teaching activities.
- 2. Proponents may submit only one application.

ART. 3. Visiting Professor

- 1. By "Visiting Professor" we refer to a professor, researcher, or expert with proven scientific qualifications, affiliated with a foreign University, Institution, or Organization.
- 2. The Visiting Professor is eligible if, in the three years preceding the deadline of the call, they have not resided or carried out their main activity in Italy for more than twelve months, even if non-consecutive.

The Visiting Professor, if retired, is not eligible.

3. The Visiting Professor cannot be simultaneously proposed for the same selection process by another Sapienza professor.

ART. 4. Hosting Department

- 1. By "Hosting Department", we refer to Department to which the Proponent is affiliated.
- 2 The hosting department must express, through a resolution of its Council <u>prior to the submission of the application</u>, a favorable opinion on hosting the Visiting Professor and granting them, in the event of funding, the status of *Visiting Professor* or *Visiting Researcher*.
- 3. The hosting department will be responsible, in the event of approval of the application submitted under this selection procedure, for managing the funding, the phases of welcoming the Visiting Professor, and fulfilling the obligations following the visit.



TITLE II - TYPES OF VISITS AND ELIGIBLE CONTRIBUTIONS

ART. 5. Eligible types of visits

- 1. Visits may be submitted for the following types of activities:
 - ioint research:
 - joint teaching.

The proposed visits may include both types of activities, but at the time of application submission, only one option must be selected based on the primary type of activity for the proposed visit.

- 2. "The following categories of visits may be proposed:
 - Category A: visits for periods of 30 days, to be carried out continuously;
 - Category B: visits for periods of 90 days, to be carried out continuously.

At the time of application submission, the Proponent must select only one option.

- 3. Category A visits can only be proposed if carried out by Visiting Professors considered outstanding researchers or professors, meaning Visiting Professors with an excellent track record, preferably holding international recognitions for achievements in the scientific and/or academic field.
- 4. "The visits must be carried out between January 1, 2026, and December 31, 2026.

ART. 6. Contributions for Visiting Professors

- 1. The contributions for Visiting Professors will be:
 - €5,000.00 gross/month for Category A visits;
 - €3,000.00 gross/month for Category B visits.
- 2. The contribution is of an income nature, though not remunerative, and is to be understood as gross of all tax charges provided for by the current legislation in the national territory, including those borne by the employer.

Regarding the tax classification of the payment and the subjective position of the recipient, mandatory social security coverage (INPS) may also apply during the period.

3. The Visiting Professor, who is fiscally resident in countries that are contracting parties to international conventions in force against double taxation, as recognized by Italian national legislation, may request the prior application of such conventions by completing and submitting to the Hosting Department the appropriate declaration issued by the competent tax authority, as provided by the applicable Convention or regulations approved by a specific provision of



the Italian Financial Administration, subject to recognition by the University through the Department.

4. The contribution granted to the Visiting Professor is intended to provide a lump-sum reimbursement of expenses, within the above-mentioned limits, always excluding any remunerative nature.

TITOLO III - SELECTION PROCEDURE

ART. 7. Applications and submission deadlines

- 1. "The funding application must be submitted by 2:00 PM on July 4, 2025, exclusively through the online procedure available at the following link https://www.uniroma1.it/it/pagina/bando-professori-visitatori
- 2. Applications must be accompanied by:
 - the curriculum vitae of the proposed scholar
 - a description of the research and/or teaching activity to be developed jointly
 - a copy of the extract of the resolution by which the Department Council commits to hosting the Visiting Professor and granting them, in case of funding, the status of *visiting professor* or *visiting researcher*.
 - If the Proponent does not have the material availability of the extract of the Department Council resolution (e.g., if it was issued close to the call's deadline), they may send a copy via email to cooperazionepvs@uniroma1.it no later than seven consecutive calendar days after the call deadline.
- 3. The resolution must have been adopted before the deadlines mentioned above and must include:
 - a) the names of the Proponent and the proposed Visiting Professor;
 - b) the category, type, and estimated period of the visit;
 - c) the favorable opinion on hosting the Visiting Professor and granting them, in the event of funding, the status of *Visiting Professor* or *Visiting Researcher*;
 - d) he department's availability to provide the Visiting Professor with adequate hospitality in terms of space, equipment, and services.
- 4. Before submitting the application, the proponent must review and be aware of the University's guidelines on "dual-use" research in collaborations outside the European Union.
- 5. Failure to provide even one of the listed documents will result in exclusion from scientific evaluation by the Commission and from this call.

ART. 8. Causes of exclusion from the selection process



- 1. Non saranno ritenute ammissibili domande di finanziamento presentate:
 - a) through methods and channels other than those provided for in the article 7;

 - c) by a proposer who does not meet the requirements set forth in the article 2;
 - d) by a proposer who has submitted another application for visiting professors within the framework of this selection process;
 - e) to invite a visiting professor who is retired;
 - f) to invite a visiting professor who has resided or carried out their main activity in Italy for more than twelve months, even non-consecutively, in the three years preceding the application deadline;
 - g) to invite a visiting professor who has been proposed within this selection process by another proposer as well;
 - h) within the framework of the Solidarity Call for Research and Teaching: Visiting Professors (both in reference to the Proponent and the Visiting Professor);
 - i) with resolutions not received within the deadlines and/or not in compliance with the provisions of Article 7 of this call.
- 2. Applications deemed ineligible pursuant to this article will not be evaluated by the committee.

ART. 9. Selection Committee

- 1. The applications will be evaluated by an internal Selection Committee appointed by the Magnificent Rector.
- 2. The Commission will be divided into two evaluation panels (joint research and teaching).
- 3. The Commission, in a plenary session, will draw up a ranking of proposals deserving of funding for each of the two types and two categories of eligible visits, until the available funds are exhausted.

ART. 10. Evaluation Criteria

- 1. Applications will be evaluated based on the primary type of activity proposed for the visit.
- 2. Applications for joint research activities will be evaluated based on the following criteria:

- 3. Applications that have received a minimum score of 18/30 will be eligible.
- 4. Applications for teaching activities will be evaluated based on the following criteria:

a) Experience and authority of the visiting professor in the relevant scientific field, assessed, when possible, according to international standards related to their publication b) Prestige of the institution of origin of the Visiting Professor c) Feasibility of the teaching activity plan to be carried out during the stay period d) Consistency between the academic profile of the proposed

- 5. Applications that have received a minimum score of 18/30 will be eligible.
- 6. The Evaluation Commitee prepares:
- the lists of applications deemed ineligible for funding, following the evaluation, highlighting insufficient scores;
- The ranking of eligible applications for funding in descending order of total score.

7. In the event of a tie in the total score, priority is given to the proposal that has received a higher score in relation to criterion (a). If the tie persists, priority is given to the application with a higher score in relation to criterion (b), and so on, following the numerical order of the technical-scientific merit criteria.

TITLE IV - OBLIGATIONS FOR MANAGING THE CONTRIBUTION

ART. 11. Obligations prior to the start of the visit



1. In case of approval of the application, the hosting Department must confirm the start and end dates of the visit by sending an email to cooperazionepvs@uniroma1.it at least 15 days before the arrival of the Visiting Professor.

The Proponent may complete the <u>form</u> for publishing the profile of the Visiting Professor on the dedicated <u>page</u> of the Sapienza website.

- 2. The Department must grant the Visiting Professor, through a Director's Decree, the status of *Visiting Professor* or *Visiting Researcher*, which will be recognized for the entire duration of the activities to be carried out at Sapienza.
- 3. Upon arrival, the Visiting Professor must demonstrate to the Department that they have appropriate health, accident, and liability insurance coverage. If the professor does not have such coverage, the Department may contact the University Services Area for Facilities-Foundations, Donations, and Insurance Services Sector-Heritage and Sustainability Enhancement Office, Heritage and Sustainability Area (email: assicurazioniateneo@uniroma1.it). The related cost will be deducted from the total granted contribution.

ART. 12. Obligations regarding the conduct of the visit

- 1. The Proponent and the Visiting Professor must carry out joint research and teaching activities in accordance with the objectives and the activity plan described in the proposal approved by the Evaluation Commission.
- 2. The duration of the visit in days will be as indicated in the proposal approved by the Evaluation Commission and must be carried out exclusively on a continuous basis.
- 3. Upon arrival, the Department will arrange for the Visiting Professor to sign the "Declaration of compliance with Sapienza Fundamental Values and Principles of Open Science, Ethics, Security for Visiting Professor Call Participation".
- 4. The Visiting Professor who is unable to carry out the scheduled visit cannot be replaced, as the contribution is nominative.

In such case, the hosting Department must promptly proceed:

- Immediate notification to the Office for International Research Planning and Management, Research Services Area (ASER) at the email address cooperazionepvs@uniroma1.it;
- Prompt return of the received contribution to the Accounting, Finance, and Salaries Area (ARCOFIS).
- 5. The received contribution will not be cumulative with other funding granted by Sapienza to the Proponent or the hosting Department to support visits of the same Visiting Professor during periods coinciding with the visit approved under this selection procedure.



ART. 13. Obligations following the completion of the visit

- 1. Within 60 days after the end of the visit, the hosting Department must proceed with the reporting by uploading the following documents in the designated completion form:
 - a) Scientific report of the activities carried out, signed by the Visiting Professor and the Proponent;
 - b) A copy of the Director's Decree granting the Visiting Professor the status of Visiting Professor or Visiting Researcher, specifying the period of stay at Sapienza, including the start and end dates of the visit.;
 - c) Financial report related to the disbursement of the contribution.

TITLE V - OTHER PROVISIONS

ART. 14. Publication

- 1. The call and the results of the selection procedure will be published on the University website at the following address: https://www.uniroma1.it/it/pagina/bando-professori-visitatori
- 2. Communications regarding funded applications will be sent to the Proponents, the Visiting Professors, and, for information, to the Directors and RADs of the respective Departments.

ART. 15. Person in charge of the procedure and references

ART. 16. Processing of personal data

- 1. The processing of personal data is governed by European Regulation No. 679 of April 27, 2016 GDPR (General Data Protection Regulation), as well as the applicable national legislation.
- 2. The personal data provided by candidates in their applications for the selection process are processed exclusively for the purposes of managing this call, both electronically and manually. The provision of such data is mandatory for the assessment of participation requirements; failure to provide them will result in exclusion from the selection process.



- 3. The legal basis for processing is identified pursuant to Article 6 of Regulation (EU) 679/2016.
- 4. The information notice is adopted pursuant to Article 13 of Regulation (EU) 679/2016.
- 5. Candidates are granted the rights set out in Articles 15 and following of the aforementioned EU Regulation 2016/679, in particular, the right to access their personal data (where applicable), the right to request its rectification, deletion (provided this does not conflict with the current regulations on data retention and the need to protect the University and professionals who have processed the data in case of legal disputes), or restriction of processing, as well as the right to object to its processing. Individuals who believe that the processing of their personal data is being carried out in violation of the provisions of the European Regulation have the right to file a complaint with the Data Protection Authority or take legal action in accordance with applicable regulations. Data will be retained (in both paper and digital format) for the time necessary to achieve the aforementioned purposes, in compliance with national and European regulations (EU General Data Protection Regulation). 6.
